UPDATE ON WORKER'S COMPENSATION CLAIMS HANDLING RFP

As we have reported previously, the Association is engaged with the City on the process to seek a new contract for Worker's Comp claims processing for the City. Earlier this month, we met with the Director of Office of Employee Relations & Human Resources, Jennifer Schembri, as well Eric Fortes, who is the new Division Manager for Human Resource's Worker's Compensation, Health & Safety.

The City has received multiple responses to its RFP, which we hope leads to a competitive process of quality bidders. We stressed with Ms. Schembri and Mr. Fortes our strong desire that whoever is contracts with the City, that an emphasis be placed on quality service that is responsive to our membership. We also stressed our desire to see a streamlined process for injured employees and retirees who need medical care and that access to actual human beings and caseworkers be available. Our goals seem to be aligned with the City as well as other employee and retiree groups.

The City anticipates returning to Council by June of this year with implementation of the contract shortly thereafter. We will keep you posted on further developments on this issue.

EFFORT TO CAPTURE EARNED SOCIAL SECURITY BENEFITS IN D.C.

As public employees who contributed to and earned our pensions, we are not eligible for the Social Security Benefits we earned prior to our public service, or the benefits we earn can be substantially reduced. This is known as the “government pension offset” and “windfall elimination” Social Security provisions. H.R. 141 was introduced into Congress last month that would eliminate both the offset and windfall elimination.

The bill has bi-partisan support with 102 co-sponsors in the House of Representatives, with 19 co-sponsors from California as of the writing of this article.

Based on our initial research it appears that the “Government Pension Offset” can reduce public employees’ Social Security spousal or survivor benefits by two-thirds of their public pension and that 9 out of 10 people lose their entire spousal benefit, even if their spouse paid Social Security taxes for many years. The “Windfall Elimination” means that those workers who paid Social Security taxes long enough to qualify for benefits can have their earned Social Security benefits reduced by up to 60%. The bill is still in its early stages and does not yet have a bill summary. That being stated, we are going to monitor this bill’s progress. The Association Board may formally vote to endorse the Bill. If that occurs, we will likely turn to the membership for action including sending e-mails and letters to the targeted Congressional Representatives. Stay tuned.
