President's Report - No Action Taken

- Retirees will not be losing their disability status due to their divorce. A tax
 attorney met with the Retirement Board and the City Attorney and gave his
 interpretation of the Muni code section that the Retirement Board interpreted
 as having to change the disability status of certain members. All parties agreed
 on the tax attorney's interpretation thus rescinding the Retirement Board's
 earlier decision. The Unions will meet with the city to change the Muni code,
 as this is a meet and confer situation.
- Discuss Ray's replacement. Ray will be moving but will continue his duties as President. His wife will either be retiring or working remotely. This is his last year as President.
- Ken does not want to continue doing both Secretary and Membership duties.
- Medicare Part B reimbursement is for both spouses, not just the retiree.
