Treasurer's Report - No Action Taken

 Treasurer Samarron provided a report on Account Balances and Income/Expenditures for July and August 2023.

Reports from Committees – No Action Taken

Old Business - No Action Taken

- US Treasuries bills. Larry has not bought any yet. He is still doing further research. Contacted Leavy group. We need the IRS number that is assigned to our tax return. Larry is waiting for the Leavy group to give us that number.
- Status on CommonWealth account. Larry needs to go to San Jose City Hall to obtain a business license which CommonWealth requires to open an account.
- Audit update. BPM CPA (bpmcap.com) did our audit in 2011/2012. They perform audits for Nonprofit organizations. Larry sent an email to BPM CPA to get more information. BPM wants to know what we want to accomplish. We want to make sure our numbers are correct and find any discrepancies. BPM recommends going back 3-5 years as going back to 2012 will cost a lot more than it's worth. Ray made the motion to go back 3-5 years. Ken made the second. Motion passed. Larry will follow up with BPM.

New Business - Action Taken None

- Maui Relief Fund. The Board discussed donating \$10,000 each to the Maui Police and Fire organizations that would go directly to their members who lost their homes. SJPOA has set up an account to donate to the State of Hawaii Organization of Police Officers (SHOPO). Dustin recommended sending Fire donations to the California Fire Foundation that has started a relief fund where 100% of proceeds will be directed to Hawaii Fire Fighters Association, IAFF Local 1463, who will directly administer aid to survivors of the fire and firefighters who have been injured and lost their homes in the wildfire. Lee Collins made the motion to donate the money. Steve O'Steen made the second. Motion passed.
- San Jose Police Foundation. Retired SJPD Captain Scott Seaman is the CEO of the San Jose Police Foundation. He asked the Association for a donation for the Major Awards Ceremony on October 26, 2023. The Board recommended donating \$2500. Lee Collins made the motion to make the donation. Ed Barbour made the second. Motion passed.
